I have a number of concerns about school reopening amid the COVID-19 pandemic. Conducting in-person lessons with students in school, even on a modified schedule that aims to reduce density, puts students, faculty, staff, and families at increased risk of disease exposure and transmission. There is no doubt that online instruction cannot fully replace the rigorous learning that occurs in the classroom. Yet returning to school this September will not, cannot, look as it did prior to school closing anyway. The benefits to learning that being together provides will no longer be able to occur. Collaboration on topics, sharing lab equipment, making music together, playing a sport, even passing papers are now all risky behaviors that we will no longer be able to do. Even conversing will become more difficult due to social distancing and face coverings. Additionally, when school is in session, safety drills such as evacuations and lock downs are required. These put students together in very tight corners. It will be profoundly difficult to conduct these drills effectively and still maintain social distancing protocols.

I terribly miss being in the classroom with my students. However, I believe that if we begin in September with clear expectations and guidelines for both online teaching and learning, and with the proper tools (ie. computers and access to the internet) in the hands of all students and staff, this form of instruction will be much improved. It is a safer alternative to returning to the buildings together without the benefit of a medical treatment for COVID-19.
